1. COURSE DESCRIPTION

AL 2290: Legal English is designed to improve your legal English skills (reading, writing, listening, speaking, and critical thinking). Through a variety of activities (individual, pair, small group, and whole class), we will:

- Read, analyze, and take notes about different legal texts (cases, articles, law school textbooks)
- Analyze videos/films about various topics related to legal English
- Use the writing process to complete short assignments related to legal writing (pre-write, draft, share your writing with others, revise, edit)
- Practice strategies to avoid plagiarizing (such as paraphrasing and citing sources)
- Organize and give short presentations
- Participate in conversations and discussions
- Use legal vocabulary and structures in your writing and speaking

2. REQUIRED MATERIALS

In this course, you will have a final project. This will be a presentation about one aspect of law, contrasting the system you are familiar with the US system you are learning about at GSU. You will work on this project in class and also have a practice presentation that will allow your classmates and the instructor to provide feedback. Your final presentation will be video recorded, and it will take place on the final day of the program.

6. QUIZZES/EXAMS

Shorter quizzes or longer exams will assess your understanding of Legal English skills, strategies, and content. They will include vocabulary and grammar structures covered in class.

7. ATTENDANCE and PARTICIPATION
